

Goals


- Development of an innovative **Joint Master Degree** in Green Energy and Finance

Organizational level


- Coordination Unit: UniBo

Structure of the work plan

WP 3-5: Design of an international multiple/joint master course


 Collect first ideas for a potential curriculum, exchange experiences about double deggree master course, legal aspects of a multiple/joint master
