WHAT:

An unmissable opportunity in the framework of the GrEnFIn project aimed to test an innovative and interdisciplinary European approach to educate the "hero of the green economy", i.e. the Sustainable Energy Expert. The path of this experience consists of two components: One taking place remotely and the other in presence, consisting of 4 days-activities in Bertinoro. In this 4 days – experience you will be involved in the resolution of technical case studies on green energy, sustainable finance, quantitative analysis, topics in economic policy and business, coherently with the practices and the needs of a large offer of market and operational contexts. All the knowledge will be applied for the case studies resolution dividing the participants in teams consisting of professionals and students which allows to simulate the natural environment in a firm, where seniors and juniors cooperate.

Step 1. A full path -- Section 1,2 and 3



These sections consist of four video Learning Units (LU) – covering material length up to 10 hours - which deal with the topics of the case study the participant will be assigned to. At the end of each learning unit, the user will have to perform a learning verification test and a satisfaction questionnaire; there is no threshold to pass the test but our suggestion is to move to the next learning unit only if you have answered at least 60% of exact answers.





Step 2. A shortcut -- Section 2 and 3



The access to **Section 2** is allowed only for those who pass an entry test based on topics of Section 1 (at least 6/10 correct answers).

Section 2

These sections consist of four video Learning Units (LU) related to the case study which the participant will be assigned to. Professionals can access the contents according to their specific individual needs and their previous experience. The length of the whole material is no longer than 8 hours. At the end of each learning unit, the user will have to perform a learning verification test and a satisfaction questionnaire; there is no threshold to pass the test but our suggestion is to move to the next learning unit only if you have answered at least 60% of exact answers.





Step 3. Section 3 only Bertinoro June 20--23

Section 3

During the 4 days programme the participants have a chance to face a project work and solve a problem based on the case study. There will be three different case study paths in which the professionals will be assigned to based on their background.

Please take into account that to benefit the most from the project we strongly recommend to carry out contents of Sections 1 and 2.
