# First Steering Committee meeting

# June 17th

The First Virtual Steering Committee meeting of GrEnFIn that was supposed to be held in Bologna, was instead took place virtually (because of the circumstances of COVID-19) through the help of Microsoft TEAMS.

As you can see the Agenda was planned in 1 hours and a half.

The meeting took place on 17<sup>th</sup> June at 2.30 PM (Brussels Time). The time table is taking as reference the Brussels Time Zone. In order to overcome the Time Zone matter, and make the meeting participation feasible for our Brazilian partner.

For this first meeting we had the chance to discuss the involvement of the Leader of the WP11 and the Associates Partners proposal.

The first point discussed were as follows:

## > WP11- DISSEMINATION AND EXPLOITATION OF RESULTS

Internal Re-organization and Coordination of Dissemination Activities

Prof. Silvia Romagnoli (UNIBO), presented the Internal Re-organization and Coordination of Dissemination Activities.

Initially, the dissemination plan and all the activities related to the WP11, were intended to be produced by Dauphine's staff, but they realized the dissemination of such a project requires specific expertise and skills both on communication and on digital dissemination and the synergy with the GrEnFIn platform is fundamental, for this reason PIXEL would certainly be better suited to do it.

Previously UNIBO sent an email asking all partners if they had internal proposals as dissemination leaders. It was therefore Dauphine who proposed PIXEL as an internal solution involving the reorganization of the dissemination activities and the relocation of the leadership of WP11. PIXEL accepted to take the role of WP11 leader.





Prof. Silvia Romagnoli asked Dr. Lorenzo Martellini to introduce PIXEL and his experience in the dissemination of European projects.

Dr. L. Martellini thanked the Scientific Coordinator of the GrEnFIn Project and Paris Dauphine for the opportunity granted explaining that PIXEL has overall 20 years of experience in coordinating European projects and that he currently coordinate 8 programmes.

He also had the opportunity to read the dissemination activities that will have to be carried out for the project, and that will present a Dissemination Plan in September.

At the end of the brief introduction, Prof. Silvia Romagnoli gave the floor to Mrs. Giulia Palermo (UNIBO) who has asked the partners for the approval of Pixel as the new leader of WP11.

Each component of the Steering Committee was called by name in order to confirmed its position with the following statement:
