Unfortunately, an exhaustive evaluation of the event is not possible in so far as part of the information is missing, including the date when it was conducted or the number of attendants. Nevertheless, the number of questionnaires submitted indicates a satisfying number of attendants, and the report also mentions that both professors and professionals were part of the group. The questionnaire design that was chosen also does not allow for a measure of the satisfaction of participants.

2.4. Local Workshop for Umbrella organisation – Bologna, Italy (D1.7)



2.5. Summer Schools and Intensive Programmes: Full Immersion Experience, Bertinoro June 2022 (D1.8)

This deliverable covers the organisation of the Full Immersion Experience, which took place in Bertinoro, Italy, at the end of June 2022. A first part relates the administrative work carried for the activation of the programme, starting from September 2021, and the elaboration of the programme's curriculum within the consortium. A second part details the application process for university students, the selection criteria applied, and the structure of the curriculum offered. The third section then provided a similar overview for the professional part of the programme. Finally, the last section summarizes the collection and dissemination of material related to the Full Immersion Experience that took place after the event.

The document is provided together with eight annexes, including documents used in the dissemination such as leaflets, and those used to define the core concepts of the programme. The main part of the deliverable would have beneficiated from further proofreading.

2.6. Reports on the validation's activities M30 (D2.4)

This deliverable provides further insight into the outcome of the Umbrella event organised by UNIBO at Prometeia Headquarter in Bologna on April 11. It first contains information on the organisation of the event, then discusses the objectives and the results from the event. On top of the results from the survey (also reported on in deliverable D10.2), the discussion of the results includes the testimony from students who were part of the pilot programme, and the outcome from the discussion during the round table. The last section covers the criticalities related to the event, starting with the low number of questionnaires collected (explained by the fact that all were filled online while the event was in presence).

The KPIs reported above for deliverable D1.7, which pertains to the same event, are also applicable to this report, but are not repeated here to avoid double counting of the same measurements.

2.7. Report based on the workshop in Munich (M30) organized to discuss the possible criticality of the tested learning outcomes (D4.5)

This report covers the organisation of an event at LMU to collect feedback from students who took part to the GrEnFIn pilot programme in the previous semester, and advertise the GrEnFIn project to a broader pool of students. The event was held online on March 24.

The document exposes the results from the event, consisting of the direct feedback collected from students during the event itself, and from the analysis of the survey from the corresponding D10.2 report. Another section then analyses the criticalities that emerged. The first one identified certain courses that students felt were missing in the curriculum, and the second criticality relates to the need for more marketing and advertisement, compared to what has been done previously. Finally, the last section reports on the discussion of the previous findings at the occasion of the sixth project meeting in Munich, including ways to collect more responses to questionnaires.

2.8. Report on the preliminary definition of the new educational methodologies to implement for the professional module (D6.3)

This deliverable reports on the design of the professional module, and the process that led to it, including how different needs were identified and taken into consideration. The report first discusses how both soft skills and hard skills are important in the profile of the sustainable energy expert, based on surveys previously conducted. In a second time, guiding principles of the module design are exposed, as well as the concrete organisation of the module for the first Summer Training. On this description, while the report provides an

extensive description of the module conception, it sometimes resorts to a rather abstract vocabulary, which obfuscates the practical aspects, and makes the implementation somewhat unclear.
