This deliverable compiles results from the three validation events that were conducted by industry partners in the last quarter of 2021. The events were organised respectively by Speed, DELAB, and MIWenergia. Evaluation results are discussed, with major inputs from respondents and criticalities identified. One critical

point discussed is the relatively low number of attendants across the board compared to the total number of invites sent (454).

One general shortcoming in the implementation of the questionnaire is that respondents were not asked which event they attended, such that the precise attribution of respondents to each event is not fully satisfactory.

2.5. Report on the organization of seminars to reach invited external stakeholders as industries and institutions and to disseminate the projects in the university not involved in the double degree agreements (Birkbeck, Paris Dauphine and WU) (D4.2)

This report provides an overall analysis of the seminars organized by the three universities of Birkbeck, Paris Dauphine and WU, with a prospect of dissemination to external stakeholders. A key goal of these events was to collect feedback on different aspects of the GrEnFIn project, and in particular with regard to the implementation of the master programme.

This report reviews the rational behind some initiatives of the project and discusses the results obtained from the events organised, mostly treated in previous reports of WP 4 and 10. The report focuses in particular on the composition of the master programme, with regard to courses that should or should not be included, all based on the feedback of seminar participants.
